Item: Naming for Online Schools

Date of Meeting: April 7, 2022

### Background:

In August 2020, in response to the pandemic, RVS decided to provide a fully online grade 1 to 12 option to RVS families. RVS had approximately 3,000 students in our RVS Online Learning option in 2020/21. On April 1, 2021, the Board directed the superintendent to continue offering a Grade 1 to 12 online option for RVS students. On June 17, 2021, the Board approved a temporary name for the new grade 1 to 9 school of RVS Elementary / Middle Online School with our grade 10-12 online offering using the previously approved RVS Online School name and school code.

In June, we stated that "the school will engage in a process involving the community (families, students, and staff) and bring forward, for the Board's consideration, any potential new name for use in the 2022/23 school year and beyond."

Current Status:

RVSO (high school with approximately 200 students) and RVSEMO (grades 1 to 9 with approximately 440 students) started operations in the fall of 2021 under these temporary school names. Part of their building of a school culture and identity is the name of the school. Each school is engaging the school community to propose some options for the Board's consideration in the spring of 2022.

Because our existing Administrative Procedure related to Naming of Facilities (AP5402) was written for traditional brick-and-mortar facilities (referencing communities and developers), we have needed to be a bit creative with this naming. School principals have formed committees and soliciting potential names. The committees will ultimately recommend at least two options for the Board of Trustees to decide in the spring of 2022.

## **Elementary/Middle School:**

The RVS Elementary / Middle Online School began the process of finding a permanent name in late October 2021 through an Ad Hoc naming committee comprised of school staff, students, parents, and Vice-Chair Lang. School community was surveyed and asked for suggestions. Over 40 suggestions were submitted and shared with all members of the Ad Hoc Committee who were asked to spend a week reviewing the submissions and narrow them down to their top 3-5 choices. Ultimately, none of the three that were identified as having the most support from the members could be used as one was the name of a living person and therefore ineligible under the RVS procedures, the second was a name that was already in use by another RVS school, and the third was very similar to an existing RVS parent app and would cause confusion if chosen. As no other names had broad support, the committee decided to workshop the problem and brainstormed two new names based on elements suggested from the survey and the previous committee discussions.

The committee suggested "Skyline Digital School" and "Rocky View Digital Pathways".

### **High School:**

The School Council Advisory Group along with Trustee Baziuk was the team that worked on the names and the process. The SCAG is comprised of a parent and three students. As a group, the committee discussed school identity then surveyed the school community. The group utilized video connections, surveys, website, social media, and newsletters. Parents and students choose to engage with the group from the standpoint of survey connection.

The committee suggested "Rocky View Mountain Virtual Education", "Rocky View Schools Online High School", and "Alberta Virtual Education".

### **Current Status:**

The Board Planning Committee reviewed the suggestions that came forward from the two committees. They appreciated the work that went into the names and asked for additional suggestions to be developed via RVS' Communications team after consulting with the two school principals. The Communications team shared a variety of potential names with the Board Planning Committee.

After considerable discussion, the Board Planning Committee recommended Discover Online for the elementary/middle school and Summit Online for the high school.

# Background:

This information item is to provide notification, in accordance with Administrative Procedure AP5201, to the Board of Trustees of purchase orders that have been issued over the amount of \$200,000.

# **Current Status:**

From Dec. 1, 2021 to Feb. 28, 2022 the following purchase orders were issued for an amount over \$200,000.

### 1. Purchase Order 101563 Issued to Bell Canada.

PO 101563, issued in the amount of \$348,126.98. This Purchase Order relates to the purchase of wireless access points and licenses.

## 2. Purchase Order 101585 Issued to MJS Mechanical Ltd.

PO 101585, issued in the amount of \$1,558,488.75. This Purchase Order relates to Q-22-04 for mechanical upgrades at George McDougall High School.

### 3. Purchase Order 101668 Issued to Insight Canada Inc.

PO 101668, issued in the amount of \$718,227.73. This Purchase Order relates to information technology software and upgrades.

Item: 2022/23 Transportation Fees

Date of Meeting: April 7, 2022

### Background:

Student transportation, and corresponding transportation fees, are governed by Policy 17 and Administrative Procedure AP5105. Each year student transportation fees are updated to reflect projected expenses and revenues of the transportation department. The fees are not implemented until approved by the Board of Trustees. Historically, fee increases have been between 0 and 30%.

The Education Act and the corresponding regulation for Student Transportation (96/2019) provides guidance to school divisions on the provision of student transportation services and potential transportation fees. The Student Fee Regulation (95/2019) also provides guidance on the implementation of school fees. Of note, the Education Act and Regulations do not require the Minister of Education approval of transportation fees.

#### **Current Status:**

Alberta Education transportation grants for 2022/23 has increased 4.6% over the 2020/21 level. The government is reviewing the school transportation system and a provincial transportation committee is studying potential new funding models for the 2022/23 school year; however, the government has indicated that the new formula may not be ready until 2023/24.

The Transportation branch continues to look for efficiencies to offset cost increases for fuel and transportation services. The branch has, over the last few years, reduced routes specific to RVS students based on updated ridership numbers as well as working with the Calgary Catholic School Division to further reduce and combine routes. RVS is once again entering a period of growth following the pandemic. Ridership is expected to increase as past students return to the transportation system and new students request service for the first time. The Transportation branch is expecting overall costs to increase due to additional routes, inflation costs of approximately 3.2% and increasing insurance and fuel costs. However, with the increased funding and a transportation reserve as a buffer, administration is recommending that transportation fees do not increase in 2022/23 and that the early registration discount incentive be increased to \$40.00 (from \$25.00) for the first two children and \$20.00 (from \$12.50) for third child and beyond.

This early registration discount incentive was well received by parents and helped RVS to pre-plan the routes for September. This early registration incentive is intended to encourage parents/guardians to register before June 24, reducing the number of last-minute transportation registrations in September, further reducing delays in the assignment of students to routes. Also, the Transportation branch will be better able to plan the routes over the summer and reduce the amount of route adjustments in September. The early partial payment provides an indication of the parents/guardian's commitment to have their children on a bus starting in September. The discounts were, last year, contingent on the fact that the children are registered and that RVS has received at least fifty percent of the total fee on or before June 24 of the prior school year. The outstanding

balance is then collected by Oct. 31. An added benefit is the ability for parents/guardians to better manage the cash flow through two smaller payments. Any registrations after June 25 would pay fifty percent of the full fee upon registration with the remaining amount due before Oct. 31. After Oct. 31 the full pro-rated fee is due upon registration.

Attached in Appendix A are the proposed fees for 2022/23. Administrative Procedure AP5105 outlines the guidelines for transportation fees.

The proposed fee structure will require RVS to budget an estimated \$250,000 of transportation reserve support in 2022/23. Administration will continue operating transportation service in a similar manner as in the 2021/22 year. The branch will continue to look for efficiencies to keep the impact to reserves as low as possible. Minor route and time adjustments may occur to meet school schedules, student needs and enrolment changes.
